# Powers Malaysia's Trade Facilitation Ecosystem





Trade processes involve a lot of document exchange and previously, the exchange of documents was done in a tedious physical manner. In a manual process, duplicate documents are required by different authorities and agencies for approval. Too often, this slows down operations within the trading community.

In Malaysia, the backbone of such electronic-based trade eco-system is the National Single Window ("NSW") for Trade Facilitation - a one-stop trade facilitation system linking the trading community with relevant Government agencies and various other trade and logistics parties through one single window, which allows for a seamless and transparent process.

An initiative of the Government of Malaysia, and led by the Ministry of Finance, Malaysia's NSW for Trade Facilitation system was launched in 2009 to simplify clearance procedures, facilitate the electronic exchange of trade-related data, reduce cost of doing business and thereby enhancing trade efficiency and national competitiveness. DNeX, through wholly owned subsidiary, Dagang Net Technologies Sdn Bhd, is the developer of the system and has been the operator since 2009.

# A SINGLE GATEWAY FOR TRADE DOCUMENT EXCHANGE

The NSW functions as a single electronic gateway for managing trade documentation required for import, export, and transit. It replaces the traditional multi-agency, paper-intensive processes with a consolidated digital platform that ensures transparency, security, and speed.

Prepares and submits electronic Customs declarations online

Allows submission of vessel and cargo manifests to respective air and sea mode authorities



Looking ahead, we are evolving the NSW to support broader regional and global trading systems. As of 2024, ASEAN countries are required to have closer integration of trading systems as part of the ASEAN Trade in Goods Agreement ("ATIGA").

The ASW implements live data exchanges with fellow ASEAN member states for preferential certificates of origin ("PCO") via the eATIGA Form D. Importers claiming preferential tariffs under ATIGA will find this integration crucial for their operations.

Through a recently signed a Heads of Agreement with Shanghai E&P International, Inc, we will collaborate on key digital trade initiatives between Malaysia and China. Both parties will focus on the following areas:

#### 1. Cross-border Visualisation of Sea Freight Logistics Movement

Enabling enhanced visibility and tracking of sea freight logistics movement and assessing the carbon footprint impact between Malaysian and Chinese ports.

#### 2. Cross-border Clearance Facilitation and Connectivity

Strengthening cooperation on processes to reach clearance and establishing connectivity with Shanghai and other regional e-ports in China.

#### 3. Trade Documents Exchange

Facilitating seamless exchange of trade documents to enhance efficiency in both trade and non-trade processes.

### DNeX IT powers Malaysian Maritime Single Window

As a maritime-focused extension of the NSW, the Malaysian Maritime Single Window ("MMSW") aligns our Malaysian ports with global mandates from the International Maritime Organization to digitise clearance processes.

MMSW is a central platform to facilitate end-to-end information flow which in turn will serve as a one-stop portal through a single sign-on and single submission for maritime regulatory and port services transactions.

And Dagang Net was entrusted by the Port Klang Authority ("PKA") to provide comprehensive services including the development, implementation and maintenance of the Malaysia Maritime Single Window ("MMSW") Phase 1.

## A seamless, borderless trade ecosystem

Our end goal is to support a fully interoperable, borderless trade ecosystem, where documentation is digitised, exchanged, and processed across jurisdictions in near real-time.
